Attention Behavioral Health Providers: Effective January 1, 2019, New 2019 Procedure Codes for Psychological and Neuropsychological Testing Services

The new 2019 Current Procedural Terminology (CPT) codes for Psychological and Neuropsychological Testing Services are effective January 1, 2019. The CPT codes utilized prior to January 1, 2019, and the new CPT codes utilized as of January 1, 2019, are listed below with descriptions:

Providers are reminded that prior authorization is required for Psychological and Neuropsychological Testing Services and to use the appropriate new 2019 CPT codes, when applicable, on claims. Any billing submitted after January 1, 2019, under the old codes needs to be promptly resubmitted under the new codes to avoid issues of timely filing.

Claims for the new 2019 CPT codes with dates of service on or after January 1, 2019, that denied with edit codes such as edit code 4801 (No billing rule for procedure) or 4014 (No pricing segment on file) because the rates are not in the system, will be automatically reprocessed. Providers do not need to resubmit or appeal the denied claims. A future web announcement will notify providers when claims will be reprocessed.
